

2024 USPC Health and Maintenance Record Book Progression D-1 to H-B

The purpose of the Record Book is to supply an outline of member's (or borrowed or virtual) mount's basic health and care information in order for someone else to care for mount if member was laid up or called away.

Records may reflect care of more than one horse but should be clearly separated.

Reference the USPC Health and Maintenance Record Book template. Candidate may begin using the template or create their own that contains the same data.
